This includes adults who have assessed care and support needs associated with older age, including illness, disability, frailty and people living with dementia. Consideration is given to individuals under the age of 55, if extra care is suitable for meeting their specific needs. The aim of the Service is to enable people who lives may be restricted by disability, illness or frailty to receive the care and support they need, in a caring and safe environment, which maximises their independence and offers choice and opportunities to lead a fulfilling life.
