Heather Court is a purpose built supported accommodation scheme with 15 self-contained one person flats, some communal space and office space & sleep-in room for support staff. The flats are let part furnished and on an assured shorthold tenancy which is renewable every six months (the maximum stay is usually two years). The building is relatively new and the standard of accommodation compares favourably when compared against other properties that are used by Children's Services. The scheme opened in October 2010 and was developed by Look Ahead in partnership with LB Havering Housing, Adult Social Care and Children's Social Services.
