The Barco weConnect solution is the only SaaS solution that provides ALL of the functions for remote teacher and student engagement required by Jisc:

- 1) Teacher view with students split across multiple screens, with configurable groups of students on each screen.
- 2) Ability to setup different room configurations within software, eg virtual classroom, collaboration room and hybrid classroom.
- 3) Polls, quizzes and student questions
- 4) Participation analysis by student
- 5) Connection of additional audio and video inputs for concurrent use.
- 6) The ability to manage all of the above through a single web interface.

Therefore we are clear that it falls within the regulation justification 32 b) ii) where services can be supplied only by a particular economic operator as competition is absent for technical reasons.
