to reflect in service planning and delivery any special support needs of minority or disadvantaged groups in the local community such as BAME groups, young stroke survivors, those in the lower socio-economic groups, those who might find services difficult to access, or who might be at higher risk of a recurrent stroke.

to build effective working partnerships and integration with key agencies, organisations, community, and voluntary groups across the whole stroke pathway. Ensuring an active member of the Integrated Stroke Delivery Network, and to embrace innovations and changes to deliver the best service possible.
