- Design services around the needs of patients and carers, ensuring they are offered more choice and a greater say in their treatment.
- Reduce unplanned admissions to hospital.
- Ensure the opening hours will enable patients to seek urgent and unscheduled, face to face treatment from a GDP outside normal practice hours.
