support recovery. The service will provide outreach and effective responses to the aftermath of a suicide. The service will provide information of support available for families and friends, enabling choice over what to access, such as individual and group counselling, and when. The provision will also include access to postvention support for staff working in mental health services. We envisage the service to be delivered by both statutory and voluntary providers through a collaborative partnership model.
