- Lot 1 exclusively - bidders opting for Lot 1 are restricted from bidding for Lot 2 or Lot 3.
- Lot 2 and/or Lot 3 - bidders may submit proposals for either Lot 2 or Lot 3 separately or for both.

If a bidder submits successful bids for multiple permitted lots, they may be awarded following:

- Lot 1 exclusively, should they wish to focus their service delivery in London area only.
