Hertfordshire County Council (the 'Council') are currently out to procurement for the commissioning of an integrated Adult Weight Management service which provides a single point of entry for patients who are eligible for Tier 2 and Tier 3 Adult Weight Management services across Hertfordshire. This service will operate as a key element of the local weight management pathway and look to have clear outcomes in both the short and long term at supporting overweight and obese adults to adopt a healthy lifestyle to lose weight and maintain a healthy weight. The estimated total value of the Contract is stated in II.1.5) of this notice and is for the initial term inclusive of the approximate value for extensions. For the avoidance of doubt, the estimated annual value of the Contract will be approximately £556071. The Contract will be awarded for an initial term of Three (3) years, with the option to extend the Contract by up to a maximum of Four (4) further years (1+1+1+1) at the Council's discretion. Please note that the contract requirements will be subject to available financial resources, supplier performance and flexibility to meet changing demands. Organisations should be aware that due to the nature of the Services provided, any Contract formed as a result of this procurement process shall be executed as a deed.
