The suicide reduction ambition sits within the context of other improvements to mental health services in the NHS Long Term Plan which will support preventing suicides, most notably: 24/7 crisis care for all ages available via 111; integrated community models for SMI which will include meeting needs for those who self-harm and with co-morbid substance use; and improving the therapeutic environment in inpatient settings
