Essex County Council (ECC) currently uses a Data Management System to manage and maintain the Greater Essex Dataset, which is a dataset of all bus routes (and associated

timetables) for every legally registered local bus service in Essex, Southend and Thurrock. From this system, weekly uploads to [data.essex.gov.uk](http://data.essex.gov.uk) are carried out in a variety of formats to support various in-house and external strategic planning data needs.

ECC is therefore undertaking a tender under FTS procedures for an initial five-year-contract from 01 April 2025 to 31 March 2030, with the option to extend for a further 3 years (1+1+1). The specification is set out in six areas of functionality:

1. Data Management System Core
2. National Public Transport Access Nodes (NaPTAN)
3. Geographic Information System (GIS)
4. Artwork Outputs
5. Reporting
6. System performance & Security
