NGN has been responsible since then for the transportation of gas to the North of England via 36,000Km of pipelines.

Currently NGN replace approximately 570km of mains and 44,000 services per year and provides 24/7 gas emergency services to our network.

Northern Gas Networks are seeking supplier(s) with proven experience and capability to supply Polyethylene Pipe and Fittings compliant to the relevant standards.
