VII.2) Information about modifications

VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

This is a national requirement for Councils to add "HIV Pre-Exposure Prophylaxis (PrEP) service specification" to their current Sexual Health contract.

Additional allocated funds from PHE to cover the routine commission of PrEP.

VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

Councils have received additional funding from Public Health England (PHE) to provide the PrEP service, & to integrate this with the current sexual health contract. PCR regulation 72.1 b is being used, although the modified value is less than 10% of the original value, estimated to be ~£59k / year, i.e. a total of £295,805 over the remainder of the contract; there is a change to the contract scope.
