- In accordance with the Faculty of Sexual & Reproductive Healthcare (FSRH) guidance, in a primary care setting to all consenting adult males who request it; and are registered with a GP practice in the commissioning areas of Norfolk and Waveney. (Subject to acceptance and exclusion criteria and thresholds).
- Compliant with the requirements of the British Association of Urological Surgeon guidelines
- In line with ICB Clinical Threshold Policy. (Sterilisation by Vasectomy and Reversal)
- Assessment of patients before embarking on any surgical using local and national guidelines and ensure compliance to any current and future NICE guidelines
- All operating staff have undertaken the relevant training and accreditation
