The existing NNS are now in their third year of delivery to Older Adults (aged 50+ years) and the next phase of their evolution is to incorporate Asset Based Community Development Principles (ABCD) into their operation. This approach is integral to the community and strength-based social work model and the overall investment by Adult Social Care (ASC) in "Prevention First". The requirement to develop community based preventative support for citizens over 18 years, with a long-term disability, is subject to approval of the Council's Budget Planning which goes to Cabinet in February 2022.
