It is HWE ICB's intention to award this contract to Steller Healthcare who HWE ICB believe are best placed to provide this intensive niche primary care provision at Gardens and Jacobs Neurological Centre in Hertfordshire, within a required 'time is of the essence' timescale for patient cohort who have complex neurological conditions including acquired brain injury, spinal injury as well as neuroprogressive conditions. The complexity of the patient cohort means this is not suitable for standard registration with a GP practice.
