The purpose of this PIN is to engage with the supply base and request information relating to the existing solutions available in the market, specifically the services include the following:

- Provide live system access to see usage in progress.
- System support/training to support usage.
- Custom reports as required.
- All invoices and debt collection to be handled directly between the partner and customer. UU shall receive volumetric payments directly from the third party.
- Delivery/collection service for standpipe hire/off-hire/exchanges within defined SLAs/KPI's.
- Defined SLAs/KPI's for customer service
