### **VII.2) Information about modifications**

#### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The contract has been modified to incorporate the provision of IUC services in Hertfordshire as well as West Essex with effect from 27 June 2024 to 31 March 2028. There is no change in the length of the contract. The modification will result in an increase to the estimated lifetime value of the contract of £73,582,683.00.

The precise annual value of the contract will be calculated in accordance with the

principles used to calculate the financial value for the period 1 April 2025 to 31 March 2026 as follows. The financial value for the period 1 April 2025 to 31 March 2026 will be the 2024-25 financial value adjusted by the national cost uplift and efficiency factors for 2025/26. The Co-ordinating Commissioner reserves the right to review the application of the cost uplifts and efficiency factors as part of the 2025-26 contract planning process.
