The Secretary of State for Defence intends to enter into a Supplies Contract with Hitachi High-Tech Analytical Science Ltd. for the supply of a handheld X-ray fluorescence analyser capability manufactured purely for the purpose of research, experimentation, study and development to enable and advance the Authority's capability to correctly and accurately assess the most appropriate recycling and disposal solution for surplus or redundant Defence assets in the field. This shall also include the creation of specific grade libraries and generation of accurate chemistry databases of Defence assets. The total value of this procurement is £25,437.00 ex VAT.
