The aim of this procurement exercise is to appoint four ECS partners to support the Capable Owner delivery model. DCC does not intend to restrict parties who are successful as one of the four ECS partners also

working as detailed designers for one or more of our D&B and Major Framework partners.

The anticipated contract value is circa £20 million per annum across the four ECS partners. It is anticipated that DCC will be delivering between £300 - £350m of project work annually over the AMP8 period including some significant standalone investigations for future AMPs, our long-term delivery strategies point to higher levels of investment within AMP9.

The ECS partners will support by undertaking data gathering, root cause analysis, modelling, solution evaluation, environmental assessments, feasibility, & optioneering to identify the optimal solution

to be taken forward into delivery. DCC's D&B and Major Framework partners will also be available to provide early contractor involvement (ECI) on the preferred solution to ensure that buildability is factored into the selected solution.
