The survey aims to allow the monitoring of trends over time and to provide results for Health Boards and local authorities and for sub-groups of the population - for example equality groups and by deprivation. The Survey is crucial to understanding changes in population health and health risk factors such as smoking, drug use, alcohol consumption, obesity diet and physical activity over time, to informing policy and demonstrating change.
