Peterlee has a population of around 20,000 residents

You are invited to tender on a contract to work in partnership with Peterlee Town Council for the Consultation, Design and Construction of a concrete skate park on Council land at Eden Lane, Peterlee. Preliminary funding of £110,000 has been secured for the project but the Town Council is open to ideas about how this could be increased through additional external grant funding and it has an upper target project value of £150,000 + VAT if additional funding can be identified.
