Explanation:

A further competition had been issued via an existing framework (procured via open procedure) for the supply of electricity however due to the current geopolitical situation, none of the suppliers on the framework were willing to enter into a fixed price contract and no bids were received by the further competition closing date of 28.02.2022. Due to the extreme and continuing market volatility, suppliers are unwilling to enter into contracts for the foreseeable future. Under Electricity (Northern Ireland) Order 1992, Electric Ireland, as the incumbent supplier, will continue to supply electricity to Fermanagh and Omagh District Council under a Deemed Contract. This arrangement will last until prevailing market conditions allow a new tendering exercise, or 31st March 2023, whichever is soonest
