- Develop inclusive approaches (face to face and virtual) to gain survivor voices, maintaining

safety and considering trauma

- Attend the Local Partnership Board to represent survivors voice (Quarterly)
- Develop routes to share information with survivors, aligning with Equation who deliver the

Promotion, Prevention and Training contract

- Seek survivor views on safe accommodation options/journeys – what works, what could be

better by 31 March 2022

- Link with the commissioned deep dive reviews to triangulate findings with local survivors
