VII.2) Information about modifications

VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

A procurement process was carried out from February to May 2022 for the reprocessing

of separately collected food waste. Following that tender a contract was awarded to Northwick Power Ltd (NPL) on 5 May 2022 and the contract award was accepted by NPL on 12 May 2022.

The contract was later repudiated (or, in the alternative, there was a material breach of contract) and the repudiation was accepted (or, in the alternative, the contract was terminated for material breach) by Warwickshire County Council on 1 August 2022.

VII.2.2) Reasons for modification

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

The contract had been awarded on 5 May 2022 and the contract award had been accepted by Northwick Power Limited (NPL) on 12 May 2022 following NPL's participation in an open procedure procurement exercise. The repudiation of the contract by NPL (or the material breach by NPL) was an extraordinary and unexpected event.
