A procurement process was carried out from February to May 2022 for the reprocessing of separately collected food waste. Following that tender a contract was awarded to Northwick Power Ltd (NPL) on 5 May 2022.

The contract was later repudiated (or, in the alternative, there was a material breach of contract) and the repudiation was accepted (or, in the alternative, the contract was terminated for material breach) by Warwickshire County Council on 1 August 2022.

The repudiation of the contract by NPL (or the material breach by NPL) was an extraordinary and unexpected event.
