undertake manufacturing trials, prototyping and Design for Manufacture Studies to allow proof of concept;

provide an emergency supply agile service should there be an emergency breakdown on plant. This will include 24/7 level of support (by exception when required) and expediting of delivery to meet urgent SELLAFIELD demands.
