The NIPACS+ solution will be implemented as a single instance across Northern Ireland for use by those involved in the delivery of care on behalf of HSCNI. HSCNI means health and social care services in Northern Ireland being acute and community services provided by the 5 health trusts, ambulance trust, general practitioner surgeries and clinics, health boards and agencies and central government healthcare services organisations ('HSCNI')..
