3iG are carrying out a major transformation of our GIS platform to the latest version of ARC GIS which is a 12 month project and contracted to 1Spatial with ESRI as a key sub-contractor.

NGN are moving to a new Utility Network Model which offers us the opportunity to purchase ELA Licences (Enterprise Licence Agreement) instead of the current fixed Maintenance Agreement, which will offer much more flexibility when buying these licences. The duration of this ELA is 5 years.
