Declarations of Interest were sought from the members of the MDT prior to consideration of contract award. No declarations of interest were declared.

The provider was assessed against 5 key criteria: Quality and Innovation; Value; Integration, collaboration and service sustainability; Improving access, reducing inequalities and facilitating choice; and social value. Each criteria was assessed on a pass/fail basis, considering whether they have currently satisfied the criteria under the previous contract and whether they would likely satisfy the proposed contract to a sufficient standard. This provider achieved a pass score against all criteria.
