The proposal is to create a pet crematorium at the existing Bradwell site to provide a local service for pet owners focusing upon individual animal cremations. The following scope sets out what NULBC are looking to procure from the market:

- The provision, installation, and commissioning of a self-contained pet cremation solution (shipping container or similar solution) able to house the cremators, ash processing machine, lifting table, staff workspace, a storage freezer along with power and lighting.
