Similarly, the service will have the ability and perspective to mobilise further services as part of the Norfolk and Waveney All-Age eating Disorders Strategy, such as ARFID (Avoidant / Restrictive Food Intake Disorder) provision in conjunction with the Integrated Care System (ICS).

Providers were asked to express an interest and were required to respond to a series of questions which were scored on a "Pass/Fail" basis.
