procurement process. The service was procured under the Light Touch Regime (LTR) of the Public Contract Regulations 2015. The process was a One Stage process.

The contract was to commence 01st April 2025 for 3 years with the Commissioner having the option to extend the Contract for up to a further 2 years.

It is important to note that this procurement included an affordability threshold. No bids over £11,851,000 per annum would be accepted. Any bids exceeding £11,851,000 per annum would be disqualified from the process.
