## II.4) Short description of nature and scope of works or nature and quantity or value of supplies or services

The purpose of this procurement, is to relocate the Royal Air Force (RAF) Centre of Aviation Medicine (CAM) from RAF Henlow to RAF Cranwell into a new purpose-built facility. This will include the design and build of the new facility at RAF Cranwell and relocation of the existing capability from RAF Henlow which may require refurbishing existing equipment or procuring new equipment to be housed in the facility to be constructed at RAF Cranwell. It is currently anticipated that there will also be a requirement to provide a support solution for the equipment to meet maintenance requirements following the relocation.
