Upon conclusion of the evaluation, the scores for 'quality' and 'price' will be combined to give a total score out of 100%, and the up to 6 Economic Operators with the highest overall score will be accepted onto the Framework Agreement.

Where there is a tie in total score (quality plus price) to two decimal places (for the final place on the Framework), WHA reserves the right to accept both Economic Operators onto the Framework Agreement.

The contracting authority considers that this contract may be suitable for economic operators that are small or medium enterprises (SMEs). However, any selection of tenderers will be based solely on the criteria set out for the procurement.
