Rebranding of existing 1 minute video and social media assets for use online and digital assets for use on digital screens and billboards

- Adaptation of assets for use on buses and bin lorries
- Distribution and development of posters, beer mats and other printed materials for use in various settings including gyms, entertainment venues and shops
- Development and delivery of a Humber wide radio campaign
