### VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

This requirement is for the Discover My Benefits Scheme (DMB) to be extended for a further 7 months. There is to be an uplift in the contract value by £450,000 from £1.71M to £2.16M. The contract requires various changes and improvements to its technical
