It will develop psychotherapeutic counsellors with the qualities, skills and competences to develop, engage in and sustain strong therapeutic relationships and enable trainees to meet the professional requirements for a High Intensity Therapist (HIT) role delivering either IPT, DIT, CTfD or PCE-CfD within adult IAPT services in England. This training programme is part of a three-year pilot that will commence in April 2022.
