II.2.4) Description of the procurement

The Royal National Orthopaedic Hospital NHS Trust (RNOH) is a specialised centre for the diagnosis and treatment of patients with complex orthopaedic conditions and cancer.

The Contracting Authority has a requirement for specialist remote radiology reporting of MRI / CT scans under the following patient categories:

- Adult and paediatric suspected sarcoma cancer, and complex tertiary care sarcoma follow up.
- Complex and specialised Paediatric scoliosis (whole spine MRIs)
- Complex tertiary care paediatric orthopaedic cases (typically post-operative)

Historically this work has been undertaken in house at RNOH due to the skills and experience required. However, due to growing demand there is a requirement for external specialist support.

The Contracting Authority intends to award a single contract to a provider able to meet the requirements set out above.

The Contracting Authority will consider which services are able to meet the requirement.

The proposed contract duration will be for a 1-year period, with the option to extend for a further 12 months.
