It is expected that the contract will go live from 1st April 2022, with access to the prison site anticipated from January 2023 and the arrival of the first wave of patients from May 2023 onwards.

The procurement will be for ONE contract for both establishments; however, each establishment is to have its own dedicated team.

HMP Onley is a Cat C prison containing a male prison population of circa 742.

HMP Rye Hill is a Cat B prison containing male population circa 664. There is to be an expansion of the prison in early 2023, this expansion will accommodate, approximately, a further 400 prisoners. This expansion has been taken into account within this contract.
