Council and Department for Education.

The provider will understand and adhere to all safeguarding and child protection requirements

as set out by the London Safeguarding Children's Board and comply with local safeguarding

processes.

The provider will work closely with a variety of council officers, health and voluntary sector partners in order to deliver the service, including (for example), Bright Start early childhood

multi-agency teams, special educational needs and disabilities (SEND) team, safeguarding and

finance officers, and the Family Information Service (FIS). Multi-disciplinary working is essential

for delivering outcomes for children and their families

before the evaluation of quality and cost. Further details will be available in the procurement

The council reserves the right to award the contract on the basis of the evaluation of initial tenders without negotiation where this offers value for money. The council reserves the right to

not award the contract if the received tenders do not offer value for money.
