Focused on stabilising a family, offering specialist interventions to parents to address psychological distress caused by childhood and other traumas, addictions and personality disorders and where appropriate keeping families together to minimise family breakdown and the numbers of children and young people coming into or returning to care.

2. Interventions may include but are not limited to: Cognitive Behaviour Support, Mentalization Based Therapy, guided self-help, counselling, behavioural activation, interpersonal therapy, eye movement. desensitisation and reprocessing, mindfulness-

based cognitive therapy, psychodynamic psychotherapy or other one to one and group intervention for psychological distress and personality disorders.
