Greater Anglia will be utilising the Rail Industry Supplier Qualification Scheme (RISQS) to undertake supplier selection.

During Market engagement, Greater Anglia intends to share the proposed Railway Industry Commodity Classification List (RICCL) codes it will be using.

Following market engagement, suppliers wishing to participate in the tender process must be qualified within RISQS for the previously shared RICCL codes and must have the capacity and capability to deliver against the criteria.

Greater Anglia reserves the right to not consider suppliers if they have not received their First Audit by the ITT submission date.

Suppliers must ensure that their RISQS membership does not lapse during the term of the procurement activity. The Company will remove Suppliers with invalid membership or subcategory codes.

Works to be undertaken could include canopy, platform and bridge refurbishments and creation and maintenance of walkways and lighting and construction of bespoke buildings within depots. The work is likely to include small elements of M&E however for larger M&E works there will be a separate lot.

maintaining various elements of M&E equipment such as station wiring, heating, cooling, lighting and power equipment. This would also include car parking and footpath lighting and barrier installation. These works are likely to include cable management systems and LV power distribution throughout the station lease areas.
