### Scope

### Description

Network Rail is issuing this preliminary market engagement notice to better understand the current capabilities of the Supply market for Road Rail Vehicles.

Network Rail Eastern Region is currently preparing to initiate a procurement process to establish a contract with a Supplier to replace up to 20 no. Road Rail Vehicle with Mobile Elevated Working Platforms and Drum Carrier Modules.

The project requires the supply of a fleet of up to 20 x medium weight OHLE RRVs 13T - 18T fitted with modular systems, including a primary Mobile Elevated Work Platform (MEWP) and a secondary drum carrier module. These vehicles will be integral to overhead line maintenance operations and are designed to enhance the efficiency and reliability of Network Rail's current fleet.
