Such surveillance requires the capability to obtain, process and analyse satellite imagery and cross reference it with Automatic Information System (AIS) data. This gives a complete picture capturing activity on AIS and dark vessels (those that do not broadcast an AIS signal). Specialist skills and capabilities are required to do this, some of which can be provided from within the MMO and some which require external procurement.

Contract value capped at maximum of £1,500,000 for first two years.
