In the interest of pure compliance, an new procurement exercise is being conducted for the same contract. Due to the limited timeframe before the existing contracts expire and the cost implication of default energy rates, as well as the comfort that a whole of market notification was previously issued on Contracts Finder, an accelerated procedure is being deployed.
