‘Towards Zero Waste’ (which requires an increase of recycling levels to 70 % by 2025). This will involve the collection, handling and disposal of specific waste streams in the most economic and environmentally conscious way. This contract will be for a period of 6 Months and the agreement is due to start by the 1st of September 2022
