Although HTE has carried out reasonable endeavours to roll out a renewal framework; due to the delays in engagement with the potential bidders and delays rolling out a renewal framework, a brief modification of the existing framework is to be carried out by extending the existing framework by 4 months. This is to ensure that public bodies are not materially impacted with the delay and a full open procedure tender process can be carried out.
