The Provider will be contracted under this Service Specification to deliver a clinician led COVID Medicines Delivery Unite Referral and Community Triage Service (the Service). The Service Specification outlines the process required for the Service to identify eligible non-hospitalised individuals for anti-viral therapy and neutralising monoclonal antibodies (NMABs), and deliver any appropriate intervention in line with the NICE Guidance.

The Contract will be for a term of nine months with the opportunity to extend for twelve months subject to mutual agreement between the successful Bidder and the Authority and availability of funding. The maximum term of Contract is consequently twenty one months.
