- (vii) any service provider delivering services to any other Government Agency in the United Kingdom including, without limitation, the Ministry of Defence and the Highways Agency

and, in the case of the organisations listed in limbs (iii) to (vii) above, who has entered into an Access Agreement with the Contracting Authority.
