#### **Clarification**

"It has come to TfWRL's attention that the contract notice and parts of Volume 1 for this tender refer in error to this tender being conducted under the open (single stage) procedure, whereas in fact (as is clear from the tender documents), it is being conducted under the restricted procedure. TfWRL is currently reviewing Volume 1 and Volume 2 to rectify this and also to clarify certain consequential matters such as the evaluation and scoring of the questions. For the avoidance of doubt, the only matters that will change will be the references to the tender procedure and clarification re: the evaluation of the questions. The specification and the content of the questions will remain the same, therefore interested participants should carry on preparing their PQQ responses based on the current specification and questions. In the interests of fairness and transparency, TfWRL will extend the deadline for submission of the PQQ responses by seven days, to 12 noon on 22nd October 2021."
